#### **DEFINITION:**

EARLY, CHILD AND FORCED MARRIAGE describes marriages in which one or both spouses are below the age of 18 or when one or both of the spouses did not give their free and full consent.

FEMALE GENITAL MUTILATION (FGM) comprises all procedures that involve partial or total removal of the external female genitalia, or other injury to the female genital organs for non-medical reasons (WHO).

#### SOME STATISTICS:

- \*By 2020, about 142 million girls will be married by their 18th birthday, a daily rate of 37,000 girls, an average of 14.2M @ year
- One third of the world's girls are married before the age of 18 (one in three girls is married before age 18 in developing countries); 1 in 9 before age 15
- 41 countries worldwide have a child marriage prevalence rate above 30%

- Around the world, between 100 and 132 million girls and women have been subjected
- · Each year, a further 2 million girls are estimated to be at risk in 28 African countries, parts of Middle East and Asian countries, and increasingly in Europe, Canada, Australia, New Zealand and the United States of America as a result of migration (WHO).

#### **REASONS FOR THE PRACTICE:**

- To preserve a tradition practiced for generations
- To alleviate poverty and to secure the girls' future because the parents feel it is for their best interest
- To conform to social norms and in many settings, it is thought to be a religious
- Other reasons include hygiene, marriageability, maintaining virginity, bride price and family honour

#### **CONSEQUENCES OF:**

- Jeopardizes girls' rights, prevents education & robs them of a chance of a career · Denies the girls a voice and say in their life choices and decisions, i.e. timing of marriage and choice of spouse
- · It leads to complications at child birth e.g. fistula: at worst, death

Short-Term complications: include risks of infections and sepsis as traditional practitioners use razor blades, knives or bits of glass to cut the delicate tissue in poor sanitary conditions; severe pain resulting into shock, blood loss resulting into death. Other complications include tetanus, urine retention, ulceration of the genital region and injury to adjacent tissues.

Long-term complications: Birth complications (obstetric fistula, C-sections, tearing); Menstrual problems; repeated FGM (re-infibulation), keloid formation, psychological trauma and infertility

#### WHAT CAN BE DONE TO PUT AND END TO THIS:

 Advocate and use the I AM SAM PEP (Prevent-to-Empower Protocol) that empowers girls at risk of child marriage FGM & protects the dignity and rights of young women and girls

- · Call on governments and leaders to enact and enforce national laws that raise the age of marriage to 18, for both girls and boys.
- Advocate for the abandonment of negative traditional values
- Advocate for actions to ensure economic and livelihood opportunities for girls out of skills, and for teenage mothers
- Engage the entire community in a dialogue with all relevant stakeholders to ensure that the communities understand the dangers of the practice and its harmful consequences on women and girls
- Facilitate increased male involvement in actions to put an end to the practice
- Enforce local legislation and domestication of international policies and laws to protect women from harmful traditional practices


